4.1. Description of first aid mea		

EYES: remove contact lenses, if present. Wash immediately with plenty of water for at least 15 minutes, opening the evelids fully. If problem persists, seek medical advice.

8.2. Exposure controls

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration.
